APPLICATION FOR ADMISSION TO FULL, ASSOCIATE OR STUDENT MEMBERSHIP

To Members of the Cosmetic, Toiletry and Associated Industries.

I would like to take this opportunity to introduce to you the Australian Society of Cosmetic Chemists and I have prepared below a brief outline of some of the objectives of the Society.

The **AIMS** of the Society are:

- a) To promote the advancement of the theory and practice of the science and technology of cosmetics, toiletries, perfumery and allied industries.
- b) To promote education, research and other means of advancing knowledge relating to the science and technology of cosmetics, toiletries, perfumery and allied industries.
- c) To institute and arrange lectures, seminars, symposia and demonstrations. In general to provide a forum for the discussion and dissemination of information relating to the science and technology of cosmetics, toiletries, perfumery and allied industries.
- d) To promote, establish and maintain the professional status of persons having scientific or technological duties within the cosmetics, toiletries, perfumery and allied industries.
- e) To publicly demonstrate the contribution of cosmetics, toiletries, perfumery and allied products to human welfare and well-being.

The **BENEFITS** of membership are:

- a) Regular Evening Seminars are held on wide ranging topics, of interest to members. These are based on the format of a seminar in conjunction with a dinner, at low overall cost. Speakers at these seminars are arranged from the industry and related areas of interest, and include visitors from overseas and interstate, as well as local speakers.
- b) A regular newsletter tells of local, interstate and international functions (I.F.S.C.C., A.S.C.C. and other societies' functions which may be of interest) for those who may be interstate and/or wish to attend specific interest seminars.
- c) An annual National Conference is organised as an all-inclusive, live-in, three-to-four day seminar including lectures, workshops and social activities. Lectures are delivered by local and overseas authorities and are well worth attending, while personal contacts made are also of great benefit and interest. These conferences are generally organised on a rotating basis around the Chapters and their branches in various Australian venues.
- d) A large International Congress is held every two years (with alternate years hosting a smaller In-between Congress Conference). These are run along the same lines as the Australian Conferences however they would have approximately 1500 delegates from all over the world and in excess of 50 international papers of world class. These conferences are generally organised on a rotating basis around the member Societies of the International Federation of Societies of Cosmetic Chemists (I.F.S.C.C.). Australia has already hosted two of these international Congresses, 1978 and 1996.

- e) Free subscription to the "Science of Beauty " magazine is included with your membership. The official magazine of the Australian Society of Cosmetic Chemists, this bi-monthly magazine includes articles, advertisements, expert columns and other items of interest to all within the industry.
- f) Access to local and internationally published articles on subjects relating to technology within the industry plus Australian Society of Cosmetic Chemists position papers on subjects of concern to the industry.
- g) Professional contacts in the Industry via the above forums.
